Permits/Mitigation Division Updates

¤ It has come to OCM's attention that there is quite a bit of confusion over plug and abandon (P&A) work and site clearance work and what does and does not require a permit. In order to clarify this issue, OCM offers the following:

As defined by OCM, P&A work means the actual physical plugging of the well (setting the plug in the well bore and officially abandoning the well). Site clearance involves the removal of structures (including but not limited to underground and surface casing/piping, keyways, platforms, boat docks, pilings, and pipelines/flowlines). Site clearance verification is the trawling around the well necessary to ensure all debris is removed.

Using these definitions, P&A work is permitted by the Office of Conservation through a work permit and does not require a separate permit from OCM. If excavation for access to the P&A site is necessary, a permit from OCM will be required for the access dredging. Site clearance work does require a permit from OCM prior to commencement of site clearance activities IF 1) the well is in an area where sensitive coastal resources (such as but not limited to oysters, natural heritage sites, wetlands, wildilfe management areas, scenic streams) are present, or 2) any excavation is necessary to remove a structure (this includes jetting to cut/remove casing, piping or pilings and to cut, cap and rebury or remove pipelines/flowlines), or 3) dredging for access is required. Excavation is defined as any movement of water bottom material by either mechanical dredging, jetting, propwashing, pushing or other type of displacement of water bottom material. - $^{\mbox{\tiny II}}$ The FY13/14 rate for monetary contribution to satisfy Beneficial Use of Dredged Material requirements is \$1.38/cu. yd. of material excavated. All applications received after July 1, 2013 for which beneficial use of dredged material is required and the monetary contribution option is selected will be charged this rate.
