NOTICE OF INTENT

Department of Natural Resources Office of Coastal Management

Administration of the Fisherman's Gear
Compensation Fund (LAC 43:I.1515)

Under the authority of R.S. 49:214.21-49:214.42 and in accordance with the provisions of the Administrative Procedure Act, R.S. 49:450 et seq., the Department of Natural Resources, Office of Coastal Management proposes to amend LAC 43:I.1515 relative to the administration of the Fisherman's Gear Compensation Fund.

The Rule change adjusts the rules for the assessment of fees to reflect the amount specified in the statute. This action is not required by federal regulation.

Title 43 NATURAL RESOURCES Part I. Office of the Secretary Subpart 1. General

§1515. Assessment of Fees

A. ...

B. The balance in the Fishermen's Gear Compensation Fund is less than \$250,000 and, pursuant to R.S. 56:700.2, (as amended, Act 337 of 1991) an additional fee of \$1,000 will be assessed on each lessee of a state mineral lease and each grantee of a state pipeline right-of-way located in the coastal zone of Louisiana, effective April 20, 1993.


