## Louisiana's Clean Marinas



The Louisiana Clean Marina Program promotes and celebrates voluntary adoption of measures to assist marinas and recreational boaters in protecting Louisiana's waters. Designated "clean marinas" are recognized as environmentally responsible businesses and enjoy the positive goodwill and positive economic benefits of being able to promote their business as a Louisiana Clean Marina.

Clean Marina Certification is achieved after a marina has met a minimum score on the checklist criteria based on BMP practices or options. Operators conduct self-assessments which will be verified by representatives of the Certification Committee. Certification is maintained through a yearly reevaluation of marina best management practices.

Louisiana's Clean Marinas will receive a certificate acknowledging their environmentally responsible actions, authorization to use the Louisiana Clean Marina logo on their letterhead and in their advertising, a flag to fly on their property, and promotion by the Clean Marina Initiative in publications, on the World Wide Web, and at public events.

LDNR Deputy Secretary Lori LeBlanc presented program certificates to several marina operators who have been designated and recognized by the state for having a "clean marina".

Becoming a clean marina means being part of a national program in which marina owners and operators take up best management practices that help protect the environment. Marinas are gateways to sensitive marine habitats that should be free of pollution and should be safe for boaters and citizens.

The program began under current LDNR Secretary Scott Angelle's tenure. The department's program goal is to reach every marina in the Louisiana coastal zone, some 50 or so, with the guidebook outlining practices and procedures for participating in the Clean Marina Program.



#### Coastal Zone Boundary Update

The Office of Coastal Management reevaluation of the coastal zone inland boundary continues to make progress, with most of the data sets now acquired and incorporated into a series of GIS layers for spatial analysis. Our workgroup of the Office of Coastal Management, private contractor, and academic staff meet regularly to review data and establish priorities for analysis. Data layers which tentatively appear promising for defining the limits of coastal processes in south Louisiana include LIDAR elevation data, wetlands distribution data, storm surge data and sea level rise estimates. We continue to review other physical and biological data too, and are continuing to seek economic and cultural data sets in a spatial data format, but these have been elusive to date. If any reader has knowledge of useful data sets, please contact the Office of Coastal Management as soon as possible so that they can be considered for inclusion in the study. The coastal zone boundary reevaluation study is a result of a Senate Concurrent Resolution (SCR 60) passed during the regular session of the Louisiana legislature this year. The resolution asked the Coastal Protection and Restoration Authority to study the issue and the CPRA tasked OCM to undertake the project. The project results are scheduled to be presented to the CPRA at the February, 2010 meeting, and after incorporating their comments, a final report is due to the legislature March 10, 2010. #### Federal Coastal Zone Management Act Update

It's now been 12 years since the CZMA has been reauthorized, and it now looks like the 111<sup>th</sup> Congress will not reauthorize it either. Although ocean issues are currently prominent in legislation, a comprehensive bill that would reauthorize CZMA appears unlikely this session. Components of what many would like to see in a new CZMA may make their way into other bills, like "cap and trade" or ocean resources bills, but the only possible option for a CZMA reauthorization would be a "straight up" reauthorization of the current act. The Office of Coastal Management Hosted Special Coastal GIS Training for Coastal Parishes' Resource Professionals on September 15-18, 2009

A two-day intermediate-level course developed by the NOAA Coastal Services Center, called Coastal Applications Using ArcGIS, followed an Introductory ArcGIS course. Exercises in this course addressed a variety of coastal issues using ArcView 9.2 technology. Problem-solving exercises integrating basic GIS topics such as metadata, scale issues, and data formats with real-world scenarios on population growth, sensitive habitats, and marine protected areas were presented.
