# March 1998 Louisiana Energy Facts Department of Natural Resources


The Louisiana natural gas average spot market price for March 1998 was \$2.19 per MMBTU. This was 44% below the January 1997 price of \$3.91 per MMBTU. For the first quarter of 1998, the average price was \$2.13 per MMBTU. This was \$0.70 per MMBTU below the 1997 first quarter average. Milder winter weather than expected in the U.S., adequate gas storage levels, additional supply from new pipelines, and low crude oil prices are the reasons for the decrease.




