
Oil use in the U.S. is up slightly for 1998. Consumption is expected to be up 140,000 barrels per day in 1998, only 0.8 percent more than in 1997. The U.S. consumed 18.6 million barrels of oil per day in 1997. Growth was slower in 1998 because motor gasoline use was up only slightly, weather was warm during the first quarter and there was a slump in the jet fuel market. Oil use is projected to rise about 1.8 percent in 1999. This projected increase is based on expectations that the demand for heating fuel and other weather sensitive products will grow and low prices will increase gasoline use.


