
The spot market price for the South Louisiana Sweet (SLS) crude oil continues to rise. The price was \$10.83 per barrel on February 16, 1999. By September 3, the price of oil more than doubled; it was \$22.19 per barrel and is expected to remain at this level for the remaining of 1999. The price increase can be attributed to the economic to the economic recovery in Asian countries, political unrest in Indonesia, labor disputes in Venezuela, and low stock in crude oil inventories.




