

The Louisiana natural gas spot market price for May, 2001 is \$4.84, a decrease of \$0.48 per MMBTU compared to April prices. According to Dynegy the decrease in May is attributed to seasonal demand drop. The May 2001 Louisiana natural gas spot market price is 59% higher than May 2000's prices. The expected natural gas prices for the summer months will higher than the same period last year.
