

Oil Prices are expected to be in a \$22 to \$28 per barrel range. This range is the favored target by the Organization of Petroleum Exporting Countries. The South Louisiana Sweet crude oil price has risen above \$30 per barrel recently. The price hike was caused by a strike in Venezuela that has stopped its oil exports, and the December OPEC accord to lower their output by more than 1 million barrels a day starting January 1, 2003. If the Middle East tensions do not escalate, the Venezuelan strike is solved, and the winter months are normal, the SLS crude oil price could move to the lower \$20 per barrel range.


