
Crude oil prices continue to rise. The spot market price for Louisiana sweet crude oil is around \$40/barrel, 41% higher than the price of \$28.30/barrel in May 2003. The value of crude oil has not reached this level since September 1990 when oil was valued at \$40.80/barrel, prior to the Gulf War. Saudi oil minister, Ali Naimi, cites, "...the market's unwarranted fear of disruptions in supplies from some oil producing countries and regions at a time when only the kingdom and probably two or three countries have spare production capacity..." as the main reason for higher oil prices. Naimi stated he will ask OPEC to raise its production ceiling by 1.5 million barrels/day, when it meets in June in an effort to ease prices.


